Terms and Conditions

Promoter	Mondelez Australia Pty Ltd (ABN 78 004 551 473), Level 10, 75 Dorcas Street, South Melbourne VIC 3205.
Competition Period	12.01am (AEST) on 11/05/2026 to 11.59pm (AEST) on 27/05/2026.
Who can enter?	Only Australian residents who are aged 18 or over
Who can't enter?	Directors, officers, management, employees and contractors (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
Entry instructions	To enter, you must, during the Competition Period: (a) click on the Promoter's advertising for the The Natural Confectionery Co. How many winners will there be and how will they be chosen?	There will be 100 winners determined in respect of this competition. There will be 1 draw conducted. The first 100 valid entries drawn randomly from the entries received during the Competition Period will each win a prize. The Promoter may draw additional reserve entries in a draw and record them in order, in case a winning entry/entrant is deemed invalid or a prize is unclaimed (Reserve Entrants). If there are less than 100 valid entries, any remaining/un-won prizes will be forfeited by the Promoter.
